**Please bring your application and the following income and expense information:**

Federal Income Tax Return (if filed, Form 1040, 1040A, 1040 EZ, Telefile Worksheets), Social Security (Form SSA-1099), Pension and Annuities (Form 1099-R), and other income documents. Also, bring documentation of deductible out-of-pocket medical expenses, including Medicare and supplemental-health-insurance premiums, payments to doctors and other licensed medical practitioners, medical equipment purchases, prescription drugs, etc.

**IF YOU DO NOT BRING YOUR INCOME AND OUT-OF-POCKET MEDICAL EXPENSE INFORMATION, WE WILL NOT BE ABLE TO HELP YOU COMPLETE THE EXEMPTION FORM.**

# Do you know anyone who might qualify for the homestead exemption?

For example, is he/she:

- 65 years of age (by January 1<sup>st</sup>)? Or,
- A 100 percent service-connected disabled veteran? Or,
- A disabled individual who requires a doctor-prescribed cane, walker, wheelchair, or prosthesis? Or,
- A mentally-disabled individual as designated by the Nebraska Department of Health and Human Services?

He/she also must meet these requirements:

- Must own and occupy his/her home.
- His/her income must be within the limits set by the Nebraska Department of Revenue.

If the above requirements are met, please give him/her this page. He/she can contact one of the organizations listed below for an application, or assistance to apply.
